PUBLIC TENDER OF BIDS FOR A 39-YEAR LEASE ON 25.86± ACRES OF DISTRICT REAL ESTATE LOCATED AT 6800 CANAL BANK ROAD IN FOREST VIEW, ILLINOIS; MAIN CHANNEL PARCEL 37.05

Sealed proposals, endorsed as above, must be submitted to the Metropolitan Water Reclamation District of Greater Chicago ("District") via an electronic upload to the Bonfire Portal only. See "Submission Via the Bonfire Portal" below for instruction. Proposal will be accepted from the date of the Invitation to Bid, up to 11:00 A.M. (Central time), on September 12, 2023.

NO BIDS WILL BE ACCEPTED AFTER 11:00 A.M. (CENTRAL TIME) ON THE ABOVE SCHEDULED DUE DATE. MAILED, EMAILED, FAXED OR HAND DELIVERED PROPOSALS WILL NOT BE ACCEPTED. THERE IS NO BID DEPOSITORY SAFE FOR THIS PURPOSE.

The land to be leased is 25.86± acres of District real estate located at 6800 Canal Bank Road in Forest View, Illinois; Main Channel Parcel 37.05. The property has roadway frontage of approximately 2,506 feet along the southeast side of Canal Bank Road, a private roadway on District property. Road access to the property is available through Canal Bank Road, which features quick access to the Stevenson Expressway (I-55) at Harlem Avenue. The site is unimproved and generally level. As of the invitation date, the site is zoned as "M-2, General Manufacturing District." The property is located in the Village of Forest View. The Village generally supports ongoing commercial use of the property. The tenant will be responsible for obtaining all necessary permits and approvals, including any required under the District's Watershed Management Ordinance ("WMO"). The District maintains records regarding the site's existing environmental condition, which can be made available for inspection upon request.

The District's Board of Commissioners has established the fair market value of the property at \$6,600,000.00 and the minimum initial annual rental bid at \$660,000.00. A form lease to be used in this transaction is attached hereto. The District reserves the right to make any changes or modifications to the lease as it deems necessary prior to award of any lease.

The lease shall be awarded to the highest responsible bidder in accordance with bid procedures set forth by state law (70 ILCS 2605/8c *et seq.*), and subject to the acceptance and approval of the bid by the District's Board of Commissioners. The highest bidder will be required to provide financial statements and/or other information to establish its financial responsibility.

Copies of the bid documents are only available online from the District's website at  $\underline{www.mwrd.org}$  (DOING BUSINESS  $\rightarrow$  PROCUREMENT & MATERIALS MANAGEMENT  $\rightarrow$  CONTRACT ANNOUNCEMENTS). Further, the District assumes no liability or responsibility for the failure or inability of any Proposer to successfully download any and all contract documents, including, but not limited to, specifications, proposal forms and/or plans, as a result of any type of technological computer and/or software system failure or breakdown that restricts, prohibits or prevents successful downloading of any and all District contract documents by the Proposer, whether caused by the District or other parties, directly or indirectly.

Proposers are to include with their proposal signed copies of any addenda, or acknowledge receipt of any addenda, if the District issued any addenda to this contract. Failure to do so may be cause for the rejection of any bid. Bidding documents are available only online, and any addenda issued for this contract will be available online at the District's website, <a href="www.mwrd.org">www.mwrd.org</a> (Doing Business  $\rightarrow$  Procurement and Materials Management  $\rightarrow$  Contract Announcements). Addenda will also be emailed/faxed to each person receiving a set of such contract documents and to such other prospective Proposers as shall have requested that they be furnished with a copy of the addenda.

If any potential Proposer contemplating to submit a proposal is in doubt as to the true meaning of any part of the specifications or other contract documents, such inquiry should be submitted online at the District's website, <a href="https://www.mwrd.org">www.mwrd.org</a>. The path is as follows: (Doing Business \rightarrow Procurement and Materials Management \rightarrow Contract Announcements). The District will provide an online response to such inquiries, as the District deems appropriate. Strings of appropriate questions and answers regarding the bidding documents will be available online on the District's website until the bid opening date of the bidding documents. No questions will be accepted by telephone, fax, email, mail or any other such form of delivery.

Each proposal must be accompanied by a bid deposit to be paid to the District via ACH (Automated Clearing House) transfer in an amount equal to fifty percent (50%) of the initial annual rental based on bidder's Proposal. Payment of such bid deposit by check of any kind will not be accepted, and all bid deposits must be received no later than the bid opening time. Any proposal submitted without a timely submitted bid deposit will not be considered and will not be read after it is publicly opened.

At the "Submit Bid Deposit" page, click the drop-down menu for this Contract No. and select this contract, then fill in all required fields. Carefully review your information on this page and each subsequent page (SUBMIT BID DEPOSIT → PAYMENT → CONFIRMATION → RECEIPT) as you will not be allowed to continue to each next page unless all required fields are properly filled in. Upon completion of the process, an email will be sent to your attention acknowledging that payment of your bid deposit has been initiated and that payment, once approved, will be applied to your account. If you do not receive a confirmation email, please check your spam and junk email folders. Ensure the MWRD emails are not filtered as spam. The required bid deposit may be forfeited, at the District's discretion, if the successful bidder fails to execute a lease agreement within 14 days of its tender. All other deposits will be returned to the respective depositors. The form of the lease currently used for this transaction is available for inspection at the District office identified below.

The successful bidder, if other than the initial applicant, will pay to the District the cost for obtaining the applicant's two (2) appraisal reports, the cost of which will be documented upon execution of the lease. In order for the initial applicant to be reimbursed for its costs in obtaining 2 appraisal reports, said initial applicant must submit a qualifying bid in this matter. In addition, if not already submitted, the successful bidder will obtain at its cost a plat of survey and legal description of the subject premises and submit same to the District within 21 days of the award.

The District reserves the right to reject any or all proposals.

The District offers all prospective tenants that are awarded leases through competitive bidding the opportunity to participate in the District's **Green Infrastructure Program**. Participation is voluntary for all private non-governmental entities. Under the program, private entities can receive a credit equal to \$0.50 on the \$1.00, up to 10% of the annual rent owed to the District, capped at the first 10 years of the lease, for expenditures related to pre-approved green infrastructure. If interested, see the *Green Infrastructure Program Information Sheet* included with this Bid Package.

The District will only respond to questions received online ONE WEEK prior to the date set to receive proposals. The District will not respond to questions received after this date. The District does not guarantee the timeliness of responses provided online, nor does the District guarantee that such responses will be provided in adequate time to affect the submission of bids. The District shall provide responses ONLY if the responses do not interpret or otherwise change the bidding documents.

The District's responses online are NOT official responses and, therefore, are not binding to the bidding documents. Any official interpretation or change to the bidding documents will be made only by addenda duly issued to all plan holders on record by the Director of Procurement and Materials Management.
